MTA Hearing on the proposed Fare Increase:

Yesterday evening I testified at the MTA Board's Hearing on the proposed fair increase at LIU in Brooklyn. I asked them to engage with the legislature to find dedicated revenue streams for both the capital and operating budgets of the MTA and to not raise the fare.

A comprehensive congestion pricing plan coupled with a corporate alternative minimum tax (referenced in my NY Daily News Op-Ed) as well as a new tax on marijuana could create the kind of revenue needed to both implement the MTA Fast Forward plan and pay for other Capital budget needs while shoring up the operating budget without raising the fare.
