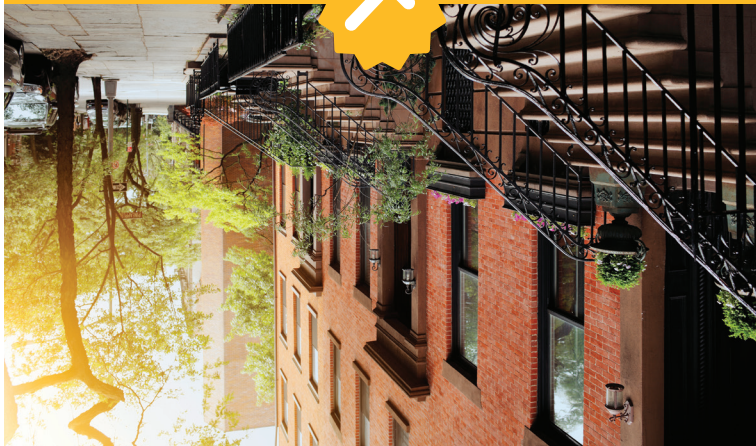

Here's what I am supporting as your Assemblyman:

- ✓ Stronger public safety: Let's increase penalties for public urination or defecation (A.4861)
- ✓ Better traffic and parking: Let's direct state and city transportation departments to assess parking availability, which can impact traffic flow and neighborhood quality of life for specific areas (A.4845)
- ✓ Responsible shelter placement: Let's make sure we're being safe and sensible by placing homeless shelters away from transit sites (A.6909)
- ✓ Safe e-bike oversight: Let's require inspection of commercial buildings where e-bikes are repaired, sold, rented or stored to ensure safety and regulatory oversight (A.4852)

- ✓ 電動單車監管：要求對維修、銷售、出租或存放電動單車的商業建築進行檢查，以確保安全與合規監管 (A.4852)
