

New York REALD What You Need to Know



Starting May 7th, New Yorkers will need a **REAL ID** to board domestic flights, enter federal facilities, and more. If you're planning to travel or visit certain federal buildings, you'll need to upgrade your current ID. Here's everything you need to know:

What is a **REAL ID?**

A **REAL ID** is a federally accepted form of identification that meets stricter security standards, as required by the federal government. It's an upgraded version of your standard driver's license or ID card.

How is a **REAL ID** different from my current ID?

While your current New York State ID or driver's license is still valid for most state purposes, a **REAL ID** is required for:

- Domestic air travel
- Access to federal facilities (like military bases or federal courthouses)
- Certain other federal services



The main difference between a standard ID and a **REAL ID** is the **black star** in the upper right corner of the card. This star indicates that the ID meets federal security requirements.

How to Get Your REAL ID

Getting your **REAL ID** is simple! Here's how to apply:

- Visit your local DMV: You can schedule an appointment online or walk in, depending on availability.
- 2. Bring required documents: You will need:
 - Proof of identity (e.g., passport, birth certificate)
 - Proof of Social Security number (e.g., Social Security card, tax form)
 - Proof of New York State residence (e.g., utility bill, bank statement)
- 3. **Pay the application fee:** There may be a fee for upgrading your license.

Key Dates

 Deadline to upgrade: All travelers must have a REAL ID or another federally approved ID by MAY 7th.
