Medical Aid in Dying Act

As a legislator and someone who has experienced the profound challenges of caring for a loved one facing terminal illness, I find myself standing at the intersection of empathy and policy, advocating wholeheartedly for the passage of the Medical Aid in Dying Act (A.995/S2445) .Tending to my father in his final moments has been a transformative experience, one that has taught me the value of empowering New Yorker's with the choice to navigate their last moments with dignity and peace. The Medical Aid in Dying Act is a law that authorizes a compassionate option that has proven not only to protect patients, but to improve care across the end-of-life spectrum.

Saving Midwifery Services at NewYorkPresbyterian-Allen <u>Hospital</u>

In response to NewYork-Presbyterian Allen Hospital announced the closure of their midwifery program. I took a stand with New York State Nurses Association (NYSNA). The preservation of Midwife services in our neighborhood are absolutely essential. The existing medical system has failed to serve Black and Brown individuals, and it is programs like the midwife program than can help ensure the safety and health of new mothers and their children.
