# **MONTHLY UPDATE**

#### **Bills Passed:**

Co-Sponsor – Directs the superintendent of banks to promulgate rules and A1476 regulations requiring licensed cashers of checks to file suspicious activity reports

A1645A -Co-Sponsor - Requires a reading proficiency level assessment and dyslexia screening for certain incarcerated individuals

A8494 -Co-Sponsor – Requires owners and agents of multiple residencies and multiple dwellings to provide names and contact information of residents to emergency personnel

A8495 -Co-Sponsor – Requires the division of housing and community renewal to provide an annual report on the New York access to home programs



## **Legislative Housing Budget Hearing**

On Feb 14, 2024, I was able to join my fellow Assembly Members and Senators to engage in a dialogue with Governor Hochul's Commissioner of New York State Homes and Community Renewal, RuthAnne Visnauskas, to discuss the 2025 Executive Budget. The hearing touched on several subjects that impact our district, including but not limited to proper oversight of capital funding, with special emphasis on Esplanade Gardens, the increased production of permanent affordable housing, independent of mixed-use buildings with Wilson Major Morris Community Center, Inc., as well as the expansion of voucher issuing and individual voucher budgets. The hearing also addressed recent legislation (A8494/S8035), the Multiple Residence Law that requires owners and agents of multiple residences and multiple dwellings to provide names and contact information of residents to emergency personnel.

### **Transportation Update**

This month, fruitful discussions were held between MTA, DOT, and the A. Philip Randolph Senior Center regarding proposed transit zone changes for a new "no standing" area and addition of a loading/unloading section in aims to elevate existing congestion.

ADA Accessibility will be coming to subways near you, with the addition of a wheelchair accessible ramp at the 3-Line Harlem-148th Street Station and proposed elevators for the 145th Street A/B/C/D Station located on Saint Nicholas Avenue.

Lastly, the 3-Line will be suspended March 11-12 from Monday 11:45 PM to Tuesday 5:00 AM. 2 trains will be making 3 stops between 135th Street and Times-Sq-42 St. A free shuttle bus will be making stops between 135th Street and Harlem 148th Street.

Stay tuned as we keep you updated on these crucial developments!

#### **Education**

In February, I was able to make tremendous strides in education advocacy. At the start of the month I was able to touch base with Manuel Ramirez, the Community School District 6 Superintendent to discuss NYC Kids Rise, a NYC Scholarship program that promotes the enrollment of NYC Students in Kindergarten - 2nd grade into the Save for College Program. Lastly, I was able to meet with Anthony Munroe, President of Borough of Manhattan Community College, to discuss CUNY's Black Male Initiative program ensuring ongoing collaboration to introduce more programming in the 71st Assembly District.

#### **Dominican Heritage**



In honor of Dominican Independence Day, I held our 5th Annual Dominican Heritage Celebration where I was able to honor Dominican Hero, Sergeant Aquilino Gonell who fearlessly protected the Capitol on the January 6th Insurrection. Sergeant Gonell served our country in the Iraq War and has continually proven his commitment to serving our country and is an exemplary member of our community.

#### **2 Saint Nicholas Place Fire**

With a heavy heart, I must share news of the tragic incident at 2 Saint Nicholas Place on Friday, February 23rd. Currently, the American Red Cross is providing assistance to 24 displaced families, including 45 adults and 9 children, who require housing, mental and physical health support, and basic necessities. Some of these individuals have found temporary shelter at the Aloft hotel on 125th Street.

In addition, we mourn the loss of a beloved member of our community, Fazil Khan, a dedicated Data Journalist. It is always devastating to lose members of our community, and our deepest condolences are extended to his family. The cause of the fire is reported to have originated from a rechargeable lithium-ion battery, underscoring the critical importance of meeting safety standards to prevent further tragedies. My office remains committed to collaborating with the FDNY and will be holding our first **Fire Safety Seminar** on **Saturday**, **May**. We hope to see you there!
