Dear Friends and Neighbors,

This week, we started Phase One of reopening the New York City region. Thanks to New Yorkers' hard work and diligence, our region is moving ahead with the reopening process. We must still adhere to public health guidelines to ensure continued progress.

June is PRIDE month. I am a proud ally standing up for the rights and visibility of the LGBTQ+ community and fighting bigotry of any kind. We will never forget the lives lost, four years ago today, in the mass shooting of LGBTQ+ individuals at the Pulse nightclub in Orlando, Florida. We will be discussing LGBTQ+ activism and advocacy at Town Hall Tuesday on June 16 at 6:30 pm. In case you missed it, I am sharing this week's Town Hall Tuesday in this special report as we were honored to be joined by our New York State Attorney General Letitia James and other leaders in the fight for Human Rights across New York State.

We made history this week in Albany, passing sweeping police reforms with the "Say Their Name" package. Our actions will repeal a state law known as 50-a, which currently seals the disciplinary records of police officers. The package also bans police chokeholds, criminalizes false race-based calls to 911, and enshrines into law the designation of the New York State Attorney General as the special prosecutor in cases where police are accused of crimes. We have all heard the call of the peaceful protesters. We must all stand for genuine criminal justice reform and against bigotry and discrimination.

The deadline to submit absentee ballots has been extended to June 23rd. To be counted, primary ballots must be postmarked by June 23rd. A previously issued Executive Order allows all New Yorkers to vote absentee in the June 23rd primary elections and ensures every New Yorker registered to vote receives a postage-paid absentee ballot application in the mail.

In Case You Missed It (ICYMI): This Week's Tuesday Town Hall on Human Rights



This week for our Virtual Town Hall Tuesday, we were honored to be joined by New York State Attorney General Tish James, Interim Commissioner Johnathan J. Smith of the Division of Human Rights, Director of Manhattan Community Service Center for New York City Commissioner on Human Rights Daryl J. Cochrane, Distinguished Lecturer and Rita E. Hauser Director of the Human Rights Program at Roosevelt House Public Policy Institute at Hunter College Jessica Neuwirth, and Anthony Browne, Hunter College Chair of the Department of Africana and Puerto Rican/Latino Studies.

SEAWRIGHT VOTES TO PASS COMPREHENSIVE POLICE AND CRIMINAL JUSTICE REFORM LEGISLATION

Repeals 50-a, Bans Chokeholds, Criminalizes False Reporting, and Enshrines AG as Special Prosecutor in Police Misconduct Cases

Assembly Member Seawright announced the New York State Assembly has passed a comprehensive package of criminal justice reforms riding on the wave of outrage following the death of George Floyd at the hands of police.

Assembly Member Rebecca Seawright, a cosponsor of the reforms, noted that actions approved on Monday would repeal a state law known as 50-a, which seals the disciplinary records of police officers. The package also bans police chokeholds, criminalizes false race-based calls to 911, and enshrines into law the designation of the New York State Attorney General as the special prosecutor in cases where police are accused of crimes.

"We have all heard the call of the peaceful protestors. We must all stand for genuine criminal justice reform and against bigotry and discrimination," Assembly Member Seawright said.

"Like most New Yorkers and most Americans, I am deeply distressed by the shocking television images of violence in major cities across the country, including here in New York State. The violence against George Floyd and Breonna Taylor by law enforcement officials, which led to their heinous deaths, must be condemned. These are terrible tragedies on a long list of an even longer history."

Assembly Member Seawright thanked Speaker Carl Heastie for his leadership in quickly moving these proposals to passage in the Assembly. "We know our work is not yet finished," said the Speaker. "We will continue fighting this week and beyond to improve police and community relations, and to create a more fair and equitable system for all people."

The legislation would also:

- mandate body cameras for all state police officers on duty.
- create the Police Statistics and Transparency (STAT) Act, which would require courts to compile and publish aggregate racial and other demographic information concerning arrests and court processing of lower-level offenses, including misdemeanors and violations. The bill also requires police departments to submit annual reports on arrest-related deaths to the Division of Criminal Justice Services, the governor and the Legislature.
- require state and local police and peace officers to report to a supervisor within six hours of the discharge of a service revolver under certain circumstances.
- amend the Civil Rights Law to affirm a person's rights in custody to prompt reasonable medical care.
- prohibit law enforcement officers from profiling based on race or ethnicity and create a statewide public database containing data on motor vehicle and pedestrian stops by police.
- allow any victim of racial or ethnic profiling, or the attorney general, to bring an action for damages or injunctive relief to stop improper profiling.

- Banned chokeholds and similar restraints

- Mandated recording demographic data in lower-level offenses
- Created the Office of Special Investigation to review wrongful death cases involving police officers
- Created the Law Enforcement Misconduct Investigative Office
- Required police to provide medical assistance to New Yorkers in custody

Phase One Overview:

Phase One industries include:

- Construction
- Agriculture, Forestry, Fishing and Hunting
- Retail (Limited to curbside or in-store pickup or drop off)
- Manufacturing
- Wholesale Trade

Re-opening refers to non-essential businesses and business activities. Essential businesses and business activities that are open will remain open.

As New York City enters phase one of reopening, Governor Cuomo announced that New York City is now eligible to resume elective surgeries and ambulatory care.

The MTA is continuing to take unprecedented steps to keep riders and workers safe, including cleaning and disinfecting trains and buses daily - the largest and most innovative cleaning effort in its history. Since May 6th, the MTA has performed 30,000 station cleanings and disinfections and 500,000 subway car cleanings and disinfections. The MTA is also piloting the use of proven UV light technology to clean subway cars and crew facilities.

To be eligible for providing oral testimony at the hearing, testimony must be submitted in writing by 5:00 pm on Monday, June 15th.
