I could not put it better than Justice Sotomayor, who said in her dissent that the ruling "threatened the very essence of public education." I am including my statement on this and the recent birthright ruling in this update.

Statement on Supreme Court Rulings on Birthright Citizenship and LGBTQ Books in Classrooms

"These rulings coming from the Supreme Court are distressing and fly in the face of American values we hold so dear.

The Supreme Court ruled 6-3 that the district court injunctions temporarily blocking Trump's order against birthright citizenship for children exceeded the District Court's authority. This decision stokes fear in immigrant communities, threatening parents who are in the country temporarily or without legal authorization and their children. Further, the ruling did not address the constitutionality of the policy itself.

As lead sponsor of the NYS LGBT Curriculum Bill, I am distressed by the Supreme Court decision in Mahmoud v. Taylor allowing Maryland parents to opt their kids out of LGBTQ+ lessons in schools. The New York Child Data Protection Act Takes Effect

Museums

The Museum of Modern Art seniors pay \$14 instead of the typical \$20 entrance fee.

The Metropolitan Museum of Art seniors pay \$22 instead of the typical \$30 entrance fee. 1000 5th Ave, New York, NY 10028

The American Museum of Natural History seniors over 60 years old pay \$22 instead of the \$28 entrance fee. 200 Central Park W, New York, NY 10024

The Intrepid Museum has a small discount for seniors over 65 years old, allowing them to pay \$34 instead of \$36. Pier 86, W 46th St, New York, NY 10036

The 9/11 Museum allows seniors over 65 years old to also receive a discount for general admission, costing \$27 instead of \$33. 420 W 14th St FI 2, New York, NY 10014

Nature & Recreation

Seniors over 62 years old can purchase lifetime tickets to **national parks**, nature refuges, national historic sites, and national monuments for \$80. Call 888-275-8747 for more information on this.

Hunting and fishing permits are discounted to only \$5 for seniors over 70 years old.

Seniors over 65 pay \$31 instead of \$35 for admission to the **New York Botanical** Gardens.

Resources

At <u>GoodCauseNYC.org</u>, a brand-new website, NYC tenants can enter their address and answer a short set of questions to determine if their apartment unit is eligible for protections, and access resources to fight back against an unjust rent hike or lease nonrenewal. The site also includes a rent increase calculator to help renters determine if their rent hike is considered "unreasonable" by the law.

Empire State Child Credit

The New York State Department of Taxation and Finance is issuing supplemental Empire State Child Credit payments to over 1.5 million low- and moderate-income New Yorkers. The 2024–2025 New York State budget provides for an additional payment to eligible taxpayers based on the Empire State child credit. If you qualify for a payment, you don't need to do anything; we will automatically calculate and send you a check for the amount you're entitled to. NYC Department of Transportation to Begin Resurfacing of the FDR North of 96th Street Throughout the Summer



New York City Department of Transportation (NYC DOT) Commissioner Ydanis Rodriguez announced the resurfacing of the FDR Drive from 96th to 125th streets during weeknight, overnight periods beginning on Tuesday, June 24, and lasting through the summer. The milling and repaving of the nearly 7.5 lane mile roadway (counting both directions) will be completed in approximately six five-night segments throughout the summer, with the goal to complete the paving for each portion by the end of each week. All work will begin at 11 P.M. each weeknight and conclude at 5 A.M. the next morning, with only one travel lane

available during the milling/paving activity. The work, which will immediately follow recently announced resurfacing on the BQE in Brooklyn, is expected to be completed, weather permitting, in mid-August.

NYC DOT will first focus on milling and repaving in the northbound direction starting at 96th Street on Tuesday, June 24, at 11 P.M. and working until 5 A.M. with just one travel lane available. For the southbound direction, work is expected to begin in early August at 125th Street and progress in the southward direction. The anticipated FDR summer resurfacing schedule is as follows (subject to change, with future updates to follow):

June 24, 2025 – June 27, 2025 (northbound) July 14, 2025 – July 18, 2025 (northbound) July 21, 2025 – July 25, 2025 (northbound) July 28, 2025 – August 1, 2025 (southbound) August 4, 2025 – August 8, 2025 (southbound) August 11, 2025 – August 15, 2025 (southbound)




