As we wind down the legislative session, my work in Albany and in the District doesn't slow down. Here are some of the things I was up to last week:



#### **Municipal Broadband Bonds Bill**

I'm pleased to announce that my broadband bill (A1260) has passed in the Assembly! This bill authorizes municipalities to sell bonds to provide funds for broadband infrastructure, a crucial step in ensuring equitable access to high quality internet connection, especially for those in rural areas or "digital deserts."



#### **Lake Friendly Living Resolution**

The Assembly also passed my resolution commemorating the Finger Lakes' community's celebration of Lake Friendly Living. Our district's integral connection to Cayuga Lake should be celebrated and respected with careful stewardship as it faces new challenges posed by climate change. Recognizing the significance of our relationship with the lake and other New York freshwater sources is key to preserving and protecting this magnificent resource for future generations.

#### **IDA Corruption Prevention Bill**

The Assembly Majority passed legislation to prevent individuals associated with any Industrial Development Authority (IDA) from profiteering off fraudulent business deals with companies that receive tax money (A4847-A). The bill would prevent IDA officials, employees, and contractors from taking positions with companies the IDA works with, cracking down on corruption.

#### **Op-Ed Supporting the Inflation Reduction Act**

The Inflation Reduction Act (IRA) is the largest investment to tackle climate change in U.S. history, offering households tax credits and rebates as well as spurring thousands of clean energy jobs in New York state and across the country. However, as I explain in my recently published op-ed, the IRA is at risk of being dismantled by Congressional Republicans as part of the debt ceiling default debate. The IRA puts money directly into New Yorkers' pockets, both from jobs and energy savings, while making our nation more competitive, secure and resilient. Lawmakers pushing for the dismantling of this act fail to see that this will risk jobs and ultimately harm their constituents.

I had the pleasure of hosting two district students, Lily Yang and Vincenzo Perfetti, 10th and 12th graders at Cortland Jr. Sr. High School, at the Assembly as part of the League of Women Voters' Students Inside Albany program. The program is designed to increase students' awareness of their responsibility in representative government and provide the tools necessary for meeting that responsibility. #### **EMS** Remembrance Event

I was honored to speak at the EMS Remembrance Event in Albany where the names of those who fell in the line of duty were placed on the Tree of Life memorial. EMS responders are the first people you see when you experience a trauma or emergency. We count on their knowledge, care and speed in times of need.

I recognize the importance of EMS services in my district, especially in the rural areas, and will continue to champion legislation that provides a stable funding stream for rural emergency medical services.

#### **Stewart Park Historic Place Designation**

I want to give my joyful congratulations to Stewart Park for being added to the National Register of Historic Places! Stewart Park has been a jewel of the Finger Lakes for more than a century, providing families and visitors enjoyment along Cayuga Lake.
