• Five local companies recently received Commercialization Assistance Program (CAP) awards, totaling \$248,300, which promote the commercialization of innovative green and clean technologies. The five companies recognized were Ephesus Technologies of Syracuse; GreenView Energy Management Systems of New Harford, N.Y; Rapid Cure Technologies of Syracuse; Synairco of Ithaca; and Synex, of Pulaski.

The Commercialization Assistance Program was first initiated in 2001 to encourage innovation, product development and entrepreneurship in the field of indoor environmental quality.

"We were confident that this matching fund program would fuel technology development, job creation and thereby

strengthen our local economy," said Assemblyman Magnarelli. "I am pleased that we are able to point to this program and see so many successes. I congratulate all the recipients in this round of CAP awards."

Combined, the projects being commercialized by these companies, thanks to funding secured by Assemblyman Magnarelli, have the potential to create 21 new jobs and retain an additional13 jobs. Over six rounds, the Commercialization Assistance Program awarded more than \$1.3 million and supported the growth and success of 26 Upstate companies.



• A Nano-chip manufacturer from Los Angeles, California recently announced its decision to move to Electronics Park and create 200 jobs in the Syracuse area. Assemblyman Magnarelli joined Senator Schumer, Assemblyman Sam Roberts, CEO Rob Simpson of Centerstate CEO, and Dr. Birendra Raj Dutt, CEO /CTO of Apix Corporation at the announcement.

This is one more step in paving the way for CNY to become a hub for high tech businesses. The Assembly announced in 2010 that the state would invest \$28 million in the Electronics Park Facility.

## **Legislative Update**

Below are several bills Assemblyman Magnarelli is sponsoring this legislative session.

#### A.3964-A Sale of Embalming Fluid

Embalming fluid, used legally by funeral directors and undertakers, is being sold illegally to drug dealers who mix it with PCP to form "water." "Water" creates an intense psychedelic high with hallucinations and other effects that cause users to act violently.

The legislation would penalize funeral directors and undertakers if embalming fluid is sold for purposes not related to funerals. The bill has been passed onto the Senate where it is sponsored by Senator Valesky.

#### A7541-A Boating While Intoxicated

This legislation would link Driving While Intoxicated to convictions for operating vehicles other than cars (such as ATVs, boats, or snowmobiles) while intoxicated. The bill is named after Tiffany Heitkamp who was killed in 2006 in a boating crash with a drunk driver. In a constituent survey sent to residents in this district, 73% of respondents said they favored the passage of this law. The bill is currently being sponsored by Senator DeFrancisco in the Senate.

#### A7845-A Hygienic Dress Code

The NYS Department of Health would create guidelines to help hospitals and health practitioners adopt a hygienic dress code restricting jewelry and certain clothing in operating rooms and medical settings. Studies have shown that ties, jewelry and other clothing carry bacteria and inadvertently pass infections to patients.

• A ssemblyman Magnarelli brought together representatives of the City of Syracuse, the Town of Geddes and the Project Engineer CH2M Hill to discuss the landscaping and other aesthetic issues involved in the final stages of the Westcott Reservoir project. Assemblyman Magnarelli provided an additional \$200,000 enabling the City of Syracuse to enhance and improve the existing storm water basins design, upgrade some of the fencing and landscaping to include decorative style fencing and additional greenery site work.
