I. COMMITTEE JURISDICTION

The New York State Assembly Standing Committee on Codes considers issues and legislation regarding the State's criminal and civil justice system. Most of the legislation considered by the members of the Codes Committee amends the Criminal Procedure Law, the Penal Law, the Civil Practice Law and Rules as well as selected articles of the Executive Law.

In addition, the Committee's dual reference authority, pursuant to Rule IV § 6 (i) of the Rules of the Assembly of the State of New York, places within its jurisdiction legislation initiated in any of the other Assembly standing committees which imposes or changes any fine, term of imprisonment, forfeiture of rights or property, or other penal sanction as well as legislation related to the procedure by which such fine, term of imprisonment, forfeiture or other penal sanction is imposed or changed.

II. SUMMARY OF LEGISLATION MOVED BY THE COMMITTEE ON CODES AND ENACTED IN 2012¹

A. <u>Protecting Children, the Vulnerable and the Elderly</u>

- **1. Prohibition on Tanning by Minors** Prohibits owners, operators, or employees of a tanning facility from allowing persons 16 years of age and under to use tanning beds and requires 17 year olds to get written parental consent to use tanning beds. (A.1074-B / S.2917-A; Chapter 105; Health)
- **2. Parking Access Aisles** Requires access aisles of parking spaces reserved for persons with disabilities to be at least eight feet wide. (A.3363 / S.3170; Chapter 274; Transportation)
- **3. Appointment of Guardians** Provides judges presiding in Mental Hygiene Law Article 81 proceedings greater information related to the criminal history records of potential guardians, which is consistent with information provided to judges in custody and visitation proceedings. (A.10608-A / S.7587-B; Chapter 475; Judiciary)
- **4. Expands Definition of Sexual Performance by a Child** Expands the definition of the crime of possessing an obscene sexual performance by a child, which is punishable as a Class E felony and bans the viewing of child pornography in digital form. The measure also provides that an attorney will not be guilty of possession of child pornography if he or she possesses the image as a part of the attorney's representation of a defendant charged with such crime. (A.10713 / S.7742; Chapter 456)

B. Protecting Against Sex Offenders

- **1. Transcripts of Parole Board Hearings** Instructs the Board of Parole to make a verbatim transcript of each parole board interview of a sex offender and provide the transcript to the Office of Mental Health for use in conducting reviews of offenders for possible civil commitment upon release from incarceration. (A.8917 / S.6785; Chapter 363; Correction)
- **2. Sex Offender Photographs** Clarifies the discretion of local law enforcement agencies to take a new photograph of a level 3 sex offender if, at the time he or she appears for a quarterly address verification, his or her appearance has changed. (A.9229 / S.7569; Chapter 364; Correction)

C. Fighting Domestic Violence

1. Domestic Violence Omnibus Bill Establishes the new E felony crime of aggravated domestic violence, committed when a defendant commits a domestic violence misdemeanor after previously being convicted of a domestic violence offense. Establishes a domestic violence fatality review team to examine the factors involved in domestic violence deaths and near-deaths and to make recommendations to prevent future fatalities. The bill prohibits persons who are the subject of an order of protection from the decedent or who are charged with the homicide of the decedent from controlling the disposition of the decedent's remains.

The legislation makes technical corrections to the confidentiality programs of the Department of State and in the Insurance Law. The measure also allows a court to consider prior violations of an order of protection and prior use of a firearm when determining the issuance of an order of recognizance or bail. (A.10624 / S.7638; Chapter 491)

D. <u>Protecting Crime Victims</u>

- **1. False Financial Claims** Requires a court, upon conviction of an individual for filing a false financial statement, to issue and file with the Secretary of State a certificate of the conviction. The bill ensures that victims have proof of the fraudulent financial statements that are being used against them and helps repair the damage caused to their credit history. (A.3457 / S.6354; Chapter 113)
- **2. Counseling Services for Families of Homicide Victims** Expands the eligibility for counseling services from the Office of Victim Services to more family members of homicide victims to include the guardians, siblings and step-siblings of victims. (A.9898 / S.6848; Chapter 233; Governmental Operations)
- **3. Determination of Incapacitation** Expands the notification requirements of the Commissioner of the Office of Mental Health (OMH) upon the discharge of a person found incompetent to stand trial to include notification to victims of domestic violence. Also requires the Commissioner to certify to the court regarding their compliance with the notification requirements of Article 730 of the Criminal Procedure Law. (A.10664 / S.6548-A; Chapter 476)

E. Making Civil Justice System Fairer

- **1. Child Support Enforcement** Expands the authority of Child Support Magistrates in Family Court to enforce child support collection laws. (A.10345 / S.7579; Chapter 468; Judiciary)
- **2. Transfer of Probation Supervision** Clarifies the court's jurisdiction and process for the transfer of probation supervision when a probationer lives or moves to another jurisdiction in cases involving child support, delinquency, PINS, and family offense cases. (A.10415-A / S.7589-A; Chapter 470; Judiciary)

- **3. Interim Probation Supervision** Provides a court with the ability to transfer the supervision of a defendant on interim probation to the county where the defendant has moved to and resides. (A.10555 / S.7190-A; Chapter 347)
- **4. Charitable Bail Organizations** Permits charitable bail organizations to post bail for certain individuals charged with crimes and provides for a certification process through the Department of Financial Services for such charitable bail organizations. (<u>A.10640-B</u> / S.7752; Chapter 181)
- **5. Electronic Filing and Litigating** Allows the Chief Administrator of the Courts to expand the use of electronic filing in litigation, including in the criminal and family courts. (A.10706 / S.7592-A; Chapter 184; Judiciary)

F. Assault

1. Social Services Employees Assault Elevates the criminal penalties for assaulting certain employees of a local social services district while they are performing their duties from a Class A misdemeanor to a Class D felony. (<u>A.4672-D</u> / S.7720; Chapter 434)

G. <u>Health and Safety</u>

- **1. Electronic Cigarettes** Adds electronic cigarettes to the provisions governing the sale of tobacco products, herbal cigarettes and shisha. (<u>A.9044-B</u> / S.2926-B; Chapter 448; Health)
- **2. Dense Breast Tissue Notification** Requires physicians to notify their patients when dense breast tissue is detected by a mammogram screening. The legislation raises awareness among women with dense breast tissue and encourages them to consult with their doctor about the potential health risks they face. (A.9586-D / S.6769-B; Chapter 265; Health)
- **3. Lauren's Law** Requires individuals who apply for a New York State Drivers License to complete the section of the application as it pertains to the organ donor registry by marking either "yes" or "skip this question" under the organ donor registry section of the application. (A.10039-B / S.7103-A; Chapter 465; Health)
- **4. Prohibit Smoking Near Schools** Prohibits smoking within 100 feet of primary and secondary school entrances and exits or outdoor areas. (<u>A.10141-B</u> / S.6854; Chapter 449; Health)
- **5. Health Care Mandatory Reporting** Requires that when a complaint of a sexual offense has been made against a licensed health care or mental health care provider during a treatment session, consultation, interview or examination, the investigating professional conduct officer or the Office of Professional Discipline must notify the appropriate law enforcement authority. (A.10336-B / S.7456-B; Chapter 365; Health)

6. Curb Prescription Drug Abuse Establishes the Internet System for Tracking Over-Prescribing (I-STOP) Act, a real-time prescription monitoring registry to provide timely and enhanced prescription information to practitioners and pharmacists. It also requires all prescriptions to be electronically transmitted with some limited exceptions.

The legislation also modifies the state's Controlled Substances Schedule by moving drugs with small amounts of hydrocodone to Schedule II and adding Tramadol to Schedule IV. Finally, the legislation directs the Department of Health to establish a safe disposal program for unused controlled substances. (A.10623 / S.7637; Chapter 447; Health)

H. Protecting Animals

- **1. Pet Dealer Animal Care** Establishes higher standards for the care of animals by pet dealers. The legislation requires dealers to make isolation areas available for sick animals, designate an attending veterinarian to establish a veterinary care program for their animals and implement an exercise plan for dogs at these facilities. (A.697-D / S.7268-A; Chapter 110; Agriculture)
- **2. Animal Cage Box Dryers** Prohibits the use of cage box dryers while heating elements are turned on in animal grooming facilities in order to prevent injury or death to animals. Under the legislation, violators face fines of not less than \$250 and up to \$500 for each violation. (A.7502-B / S.5702-A; Chapter 119; Agriculture)
- **3. Animal Fighting Paraphernalia Banned** Prohibits the ownership, sale, transfer and manufacture of animal fighting paraphernalia. (<u>A.9552-A</u> / S.6774-A; Chapter 144; Agriculture)

I. Protecting Consumers

- **1. Social Security Number Protection** Prohibits any person from knowingly using the labor or time of prison inmates to collect, access, or process the Social Security numbers of New York State consumers. (<u>A.8375-A</u> / S.7594; Chapter 371; Consumer Affairs)
- **2. Electronic Fund Transfer Protection** Prohibits the transfer of funds as a penalty for providing final payment after a bank account holder has given oral or written communication to stop preauthorized electronic fund transfers. (A.9787 / S.219-A; Chapter 403; Banks)
- **3. Ticket Sales for Entertainment Events** Extends the current regulations for the sale and resale of tickets to places of entertainment to 2013, continuing consumer protections for the free market sales of tickets and the prohibition against restricted paperless tickets. (A.9844 / S.6481-A; Chapter 28; Tourism)

4. Telemarketing Restricting Requires out-of-state telemarketers to register with the Department of State and all telemarketers to obtain authorization from the consumer prior to transmitting prerecorded messages, commonly known as robocalls. (<u>A.10569-A</u> / S.7567-A; Chapter 369; Consumer Affairs)

J. Expanding the Use of DNA and Protecting the Innocent

1. DNA Testing Expands the collection of DNA samples from defendants convicted of crimes in New York State to include all felonies and all penal law misdemeanors. The legislation also enhances the protections afforded to defendants seeking to demonstrate their innocence by providing access, in certain circumstances, to post-conviction DNA testing and comparisons. In addition, the legislation provides for the ability of the court to order discovery for convicted defendants who file a post-conviction motion seeking to demonstrate actual innocence. (A.9555 / S.6733; Chapter 19)

K. Miscellaneous Legislation

- **1. Possession and Sale of Embalming Fluid** Prohibits the sale of embalming fluid by a funeral director, undertaker, embalmer, or registered resident to anyone other than a licensed funeral director, undertaker, embalmer, registered resident or other entity authorized to perform embalming activities. (<u>A.3964-A</u> / S.657-A; Chapter 29)
- **2. Access to the Adoption Registry** Allows persons born in another state, but adopted in New York State, and their birth parents and siblings, to be added to the adoption registry. (A.8307 / S.5145; Chapter 480; Health)
- **3. NYC Taxi Licenses** Authorizes New York City to sell 2,000 accessible taxi licenses and 18,000 HAIL licenses. Under the legislation, the HAIL licenses will allow livery cars to pick up street hails in northern Manhattan, Bronx, Brooklyn, Queens and Staten Island. (A.8691-A / S.6118-A; Chapter 9; Cities)
- **4. Qualified Agencies** Defines the Division of Forensic Services of the Nassau County Medical Examiner's Office as a "qualified agency" for the purpose of accessing the Division of Criminal Justice Services' (DCJS) database containing criminal history and fingerprint information. (A.9098 / S.6280-A; Chapter 14)
- **5. Expansion of the Iranian Divestment Act of 2012** Adds SUNY, CUNY and public authorities to the list of state entities that are prohibited from investing in the Iranian energy sector. (A.9224 / S.6462; Chapter 106; Governmental Operations)
- **6. Muni-Meter Parking** Provides an affirmative defense to a parking ticket if a munimeter receipt was purchased before, or up to five minutes after, a ticket was issued. (A.9353-C / S.6727-B; Chapter 486; Transportation)

- **7. Voluntary Surveillance Access Database** Establishes a voluntary surveillance access database. Under the legislation, homeowners and business owners can participate in a program that permits the location of private security cameras or other electronic video surveillance systems to be made available to law enforcement agencies to help solve crimes and apprehend criminals. (A.9380-B / S.7775; Chapter 287)
- **8. Powers of District Attorney** Codifies the authority of district attorneys to employ or contract with social workers, and retroactively provides that time worked for a district attorney's office would count toward experience requirements for persons seeking licensure in that field. (A.10553-A / S.7538; Chapter 358)

III. SUMMARY OF SIGNIFICANT LEGISLATION MOVED BY THE COMMITTEE ON CODES IN 2012 THAT ONLY THE ASSEMBLY PASSED²

A. Protecting Children, the Vulnerable, the Elderly and Victims of Hate

- **1. Office of the Child Advocate** Establishes the independent Office of the Child Advocate, headed by the Child Advocate appointed by the Governor. The Child Advocate, who would report to the Governor and Legislature, would monitor the implementation of policies concerning children in the care, custody or guardianship of the state and make recommendations regarding changes to such policies. (A.644-D/S.7678; Passed Assembly; Children and Families)
- **3. Toxic Chemicals in Children Products** Provides greater regulation and awareness of the use of toxic chemicals in children's products by requiring the Department of Environmental Conservation to establish and maintain a website that identifies chemicals that are harmful to human health and found in products used by children. The bill also would prohibit the sale of children's products containing such chemicals unless DEC provides a waiver. (A.3141-A/S.1526-B; Passed Assembly; Environmental Conservation)
- **4. Parental Notification of a Youth's Arrest** Requires law enforcement officials, upon the arrest of an individual between 16 to 18 years of age, to notify the parent or person who is legally responsible for that teenager. In addition, the bill would require the parent to be notified if a court appearance ticket has been issued to the youth, unless such a notification would endanger the health and safety of the individual. (<u>A.4408</u>/ S.3202; Passed Assembly)
- **5. The Safe and Fair Equal Treatment for Youth Act (SAFETY)** Requires the commissioner of the Office of Children and Family Services (OCFS) to develop policies that prevent OCFS staff from engaging in harassment and discrimination against youth residing in facilities operated by OCFS. The legislation mandates that the SAFETY Act's policies be publicly posted and incorporated into the training of OCFS personnel. (A.4426; Passed Assembly; Children and Families)
- **6. Notice of Placement Changes and Reports of Child Abuse in Foster Care Homes** Seeks to ensure the safety of children placed in foster care by requiring that local social services districts timely (within ten days) notify the child's attorney when changing the placement of that child, unless such a change was necessitated by an emergency. The bill, also, requires a local district to notify (within five days) the attorney for the child and the attorney for the other involved parties, of an indicated child abuse report that involves the foster child or another child in the home. (A.7598/ S.5456; Passed Assembly; Children and Families)

Additionally, legislation that was in fact passed by both Houses will be listed as such.

- **7. Sharing Mental Hygiene Records** Provides that information obtained pursuant to "Jonathan's Law," can be shared with health care providers, behavioral health care providers, law enforcement entities, and when criminal activity is suspected, the recipient's attorney. (A.9037-A/ S.6620-A; Passed Assembly; Mental Health)
- **8. Child-Sensitive Arrest Policies** Directs the superintendent of state police to develop and institute child-sensitive arrest policies and procedures. (<u>A.9087-A</u>/ S.6043-A; Passed Assembly)
- **9. Baby Crib Safety** Prohibits the use of unsafe cribs in child care facilities and places of public accommodation, such as hotels, motels, inns, and motor courts. (<u>A.9437/</u> S.7568; Passed Assembly; Consumer Affairs)
- **10. Extension of "Jonathan's Law"** Provides that family members of individuals receiving services in mental hygiene facilities have access to the service recipient's records. (A.9777-A / S.7475-A; Passed Both Houses; Mental Health)
- **11. Permanency Planning in JD and PINS proceedings** Requires permanency planning in juvenile delinquency (JD) and persons in need of supervision (PINS) proceedings to enable the person's immediate school enrollment, parental notification about the proceedings, and the continued legal representation at such proceedings. (A.10348/ S.7591; Passed Assembly; Children and Families)
- **12.** Increase Access to PINS in Family Court for Certain Youth Allows a person in need of supervision (PINS) petition to be filed, without attempting diversion services, in two narrow instances when diversion would not be feasible: 1.) when the youth has run away and a warrant is needed, or 2.) when the youth poses an imminent risk of harm to his or her family and an order of protection is required. Once the youth is returned to court, diversion would be required unless there is a substantial likelihood that the youth would run away or pose imminent harm again. (A.10639/ S.7586; Passed Assembly; Children and Families)
- 13. Justice Center for the Protection of People with Special Needs Establishes uniform safeguards for people with special needs who are being cared for in residential facilities and day programs by provider agencies that are operated licensed or certified by state agencies. The bill establishes safeguards to be implemented by a newly created Justice Center for the Protection of People with Special Needs. The Justice Center will contain both an inspector general and a special prosecutor, vested with concurrent jurisdiction with local district attorneys to prosecute cases of abuse and neglect in which people with special needs have been victimized.

The legislation, further, establishes a 24/7 hotline to receive reports of abuse, neglect, and other significant incidents. In addition, the measure establishes a central registry for employees found guilty of certain allegations of abuse and neglect. Such individuals would be permanently barred from employment in any of the impacted state agencies. (A.10721 / S.7749; Passed Both Houses; Mental Health)

B. Protecting the Public Against Sex Offenders

1. Development of Guidelines for the Treatment of Victims of Sex OffensesRequires the Office of Mental Health and the Office of Alcoholism and Substance Abuse Services to develop guidelines regarding the services available to victims of sex offenses in outpatient settings. Under the bill, such guidelines would include evidence-based, best practices on how to ensure victims are not re-traumatized by known sex offenders during treatment. (A.6573-B/S.7069-A; Passed Assembly; Mental Health)

C. Protecting Crime Victims and Victims of Domestic Violence

- **1. Aggravated Family Offense** Establishes the felony crime of aggravated family offense for individuals who commit a specified domestic violence misdemeanor offense and have been convicted of one or more domestic violence offenses within the past five years. (A.1986-B/ S.5822; Passed Assembly)
- **2. Domestic Violence Workplace Discrimination** Prohibits employers from discriminating against domestic violence victims and provides accommodations to victims when they must be absent from work for a reasonable time due to domestic violence. (A.2348-A/ S.5526; Passed Assembly; Governmental Operations)
- **3. Domestic Partner Crime Victims' Compensation** Expands eligibility for those who receive crime victim compensation awards to include a domestic partner and provides access to counseling for surviving family members of homicide victims. (<u>A.3592</u>/ S.629; Passed Assembly)
- **4. Serious Offense Definition** Expands the definition of "serious offense" in the Penal Law to include certain domestic violence offenses and prohibits persons convicted of such offenses from possessing a firearm. (<u>A.4488-A</u>; Passed Assembly)
- **5. Domestic Violence Housing Discrimination** Classifies the denial of housing and other accommodations to victims of domestic violence as an "unlawful discriminatory practice" when such denial is based on their victim status. (A.9024/ S.6994; Passed Assembly; Governmental Operations)

D. Fighting Gun and Weapon Violence

- **1. Firearm Microstamping** Establishes the Crime Gun Identification Act of 2012 that would require all new semiautomatic handguns sold in New York State, by 2014, to be microstamped with a unique code which is transferred to shell casings when the gun is fired. (A.1157-B/ S.675-C; Passed Assembly)
- **2. Firearm Ownership Inquiry** Requires the judge in a criminal proceeding or in a family court proceeding, upon issuance of an order of protection, to inquire as to the ownership of a firearm by the defendant or respondent. (<u>A.2494-B</u>/S.1003; Passed Assembly)

- **3. Revocation of Firearms Licenses** Empowers courts to revoke firearms licenses and seize weapons from individuals who are ordered into treatment at a mental health facility or whom a judge has determined are incapacitated. (<u>A.3081/S.670</u>; Passed Assembly)
- **4. Undetectable Knives** Prohibits the manufacture, transport, shipment or possession of an undetectable knife for commercial sale and requires that manufacturers of knives include materials that are identifiable and detectable by a metal detector. (<u>A.3622-A</u>; Passed Assembly)
- **5. Revocation of Firearm License Involving Orders of Protection** Provides for the mandatory revocation or suspension of the firearms license of an individual against whom an order or temporary order of protection has been issued. (<u>A.6406-A</u>/ S.7205; Passed Assembly)

E. Expanding the Use of DNA and Protecting the Innocent

1. DNA / Innocence Omnibus Bill Establishes statewide standards for the preservation and cataloguing of DNA evidence. The measure also creates the Integrity of the Criminal Justice System Commission to study the errors made in wrongful conviction cases and to make recommendations to prevent such breakdowns in the justice system.

The bill also ensures confidentiality of those who provide voluntary samples; eliminates unregulated, "rogue," DNA databases; expands access for those who have been wrongfully convicted to seek monetary damages; and mandates the videotaping of custodial interrogations conducted in police stations for felony cases. (A.5886-C; Passed Assembly)

- **2. Discovery** Establishes the power of a court to order disclosure by the prosecution of relevant property that is shown to be material to the case of the defense, whether or not the prosecution intends to introduce the property at trial. (A.8080; Passed Assembly)
- **3. Fingerprint Comparison** Allows a court, upon a pre-trial motion by the defendant, to order that a fingerprint obtained in the course of an investigation be compared against the state and or national fingerprint identification system upon a showing that such comparison is material to his or her defense. (A.10269; Passed Assembly)

F. Gang Prevention

1. Gang Program Establishes a gang assessment, intervention, prevention and suppression program within the division of criminal justice services. (A.3834-A; Passed Assembly)

G. Protecting Animals

1. Ban on Needless Devocalization of an Animal Prohibits the removal of the vocal chords of a dog or cat for non-medical reasons. Under the bill, violators would face fines or incarceration and may be required to forfeit ownership of their pet. The legislation also requires the suspension or revocation of a veterinarian's license if convicted of performing an illegal devocalization. (A.3431-D/ S.6167-C; Passed Assembly; Agriculture)

H. Protecting Consumers

- **1. Predatory Gas Pricing Prohibited** Prohibits multiple gasoline price increases in a 24-hour period. (A.1970/ S.603; Passed Assembly; Governmental Operations)
- **2. Preventing Random Gas Pump Price Increases** Redefines the permitted "additional costs" for gas to only include taxes and transportation costs and prevents wholesalers, retailers, and gas station owners from randomly increasing the price of gas, as frequently occurs in major metropolitan areas. The bill also prevents unfair gas pricing that is based on geographical location rather than on actual costs. (A.7775-B/S.4170-B; Passed Assembly; Economic Development)
- **3. Recourse for Price Gouging Victims** Empowers price gouging victims to sue price gougers directly while retaining the current authority of the state Attorney General to also bring legal action against violators. The bill also permits victims of price gouging to receive compensation for actual damages or \$1000, whichever is greater. In addition, the measure permits the court to award an additional penalty of up to \$5,000 for a willful or knowing violation as well as reasonable attorney's fees. (A.8340; Passed Assembly; Consumer Affairs)
- **4. Foreclosure Fraud Prevention Act** Establishes "the foreclosure fraud prevention act of 2012" and creates two new crimes of residential mortgage foreclosure fraud in the first and second degrees. (A.10629-A/S.7759; Passed Assembly / S.7759; Rules)

I. Housing Protection

Vacancy Decontrol Repeals vacancy decontrol laws that permit landlords to remove rent-regulated apartments from regulation when rent equals or exceeds \$2,000 per month. (A.2430-A/ S.1193-A; Passed Assembly; Housing)

Landlord Apartment Personal Use Restrictions Permits landlords to take possession of one unit for their own primary residence in cases of immediate and compelling necessity except when a tenant has occupied the apartment for 20 or more years, in which case the unit cannot be recovered by the owner for his or her personal use. (A.3033/S.81; Passed Assembly; Housing)

Rent Overcharge Complaint Requires an owner of a rent-regulated unit to comply with an administrative order issued more than four years prior to an overcharge complaint, as long as the order has not been revoked. This bill also requires a complaint of fraud to be reviewed by the Division of Housing and Community Renewal without regard to whether such fraud allegedly occurred prior to the four years preceding the filing of a complaint. (A.4900; Passed Assembly; Housing)

J. Making Civil Justice System Fairer

- **1. Filing of Satisfaction of Judgment** Increases the penalties for judgment-creditors who have received full payment on judgments but do not file the appropriate satisfaction in court, thus further impairing the credit of judgment-debtors. (A.1889-B/ S.438-B; Passed Assembly; Judiciary)
- **2. Exclusion of Judgments** Excludes certain judgments, orders, or decrees issued in a matrimonial action, including an award for maintenance and or child support, from a stay of enforcement without a court order. (A.5032-A; Passed Assembly)
- **3. Prohibition of Denial of Class Certification** Prohibits a court from denying class certification in a class action lawsuit solely because the action involves governmental operations. (A.2334/ S.5327; Passed Assembly)
- **4. Translation of Orders of Protection** Requires the essential terms of an order of protection to be translated into the native language of the parties involved by an interpreter appointed by the court to assist in the proceedings. (A.6113/ S.1870-A; Passed Assembly; Judiciary)

K. <u>Drug Prevention</u>

- **1. Prohibition of Salvia Divinorum** Prohibits the sale of salvia divinorum, an herbal intoxicant, to persons under 18 years of age. (<u>A.5491</u>; Passed Assembly)
- **2. Synthetic Marijuana Banned** Criminalizes the sale and possession of synthetic marijuana in New York State and adds several chemical compounds used to manufacture synthetic marijuana to the schedule of controlled substances, making the sale and possession punishable by imprisonment, a fine, or both. (A.9855-A; Passed Assembly)

L. Police and Community Relations

- **1. Geographical Area of Employment** Expands the geographic area used to determine eligibility for employment as state university police officers to the areas adjacent to the campus. (A.5372-B; Passed Assembly)
- **2. Racial Profiling** Prohibits law enforcement officers from using racial profiling. Under the bill, police departments would be required to collect and maintain records related to traffic stops and "stop and frisk" actions and regularly submit the information to the Division of Criminal Justice Services. This bill also permits victims of profiling to seek recourse against those who solely use race and ethnicity as a basis for exercising the powers of law enforcement. (A.2288; Passed Assembly)

M. Protecting Public Health

- **1. Ensuring Proper Treatment of Drilling Waste** Requires that waste resulting from the production or exploration of oil or natural gas be considered hazardous if the waste meets the state Environmental Conservation Law's definition of hazardous. (A.7013/S.4616; Passed Assembly; Environmental Conservation)
- **2. Disaster Safety for Individuals with Disabilities** Requires counties to maintain voluntary registries of people who may be in need of special assistance in the event of an emergency or disaster. (A.7257; Passed Assembly; Governmental Operations)
- **3. Medical Marijuana** Permits the use of marijuana to treat serious, life-threatening illnesses under a doctor's supervision. The bill requires that a licensed practitioner certify that a patient has a serious condition for which they are likely to receive palliative or therapeutic benefit from treatment which includes the medical use of marijuana. Under the bill, a certified patient or designated caregiver, who is required to be registered with the state Department of Health (DOH) will be permitted to possess up to two and one half ounces of marijuana.

Also, the bill authorizes DOH to license and regulate "registered organizations and producers" to dispense medical marijuana to certified patients. Lastly, it requires DOH to issue registry identification cards to certified patients and designated caregivers. (A.7347/ S.7283-A; Passed Assembly; Health)

N. Promoting Driver Safety

- **1. School Bus Safety** Establishes a School Bus Motorist Education Program to educate motorists of the dangers of passing stopped school buses in order to reduce the number of violations and promote school bus passenger safety. (A.1178/ S.5741; Passed Assembly; Transportation)
- **2. Seat Belts in Rear Seats** Prohibits any person from riding in the rear seat of a motor vehicle unless they are properly restrained by a seat belt. (<u>A.1306</u>/ S.1337; Passed Assembly; Transportation)

3. Insurance Fraud Prevention Expands the definition of insurance fraud in the fourth degree, a Class E felony, to include a person who commits an act of insurance fraud and operates a motor vehicle and intentionally causes or attempts to cause a collision. (A.6177-A; Passed Assembly)

O. Miscellaneous Legislation

- **1. Diplomatic Immunity Notification Act** Requires notification to certain federal and state agencies when persons who act in violation of New York's laws claim diplomatic immunity. The notification must include the name of the protected person, their title, position, and/or assignment, in the United States, and information about the incident, including the potential violations of the penal law. (A.291-A/S.7262; Passed Assembly)
- **2. Gender Expression Nondiscrimination Act** Protects transgender people under the Human Rights Law by prohibiting discrimination based on gender identity or expression. (A.5039/ S.6349; Passed Assembly; Governmental Operations)
- **3. New York State Fair Pay Act** Prohibits an employer from discriminating against employees on the basis of sex, race and/or national origin by paying different wages. (A.6130-A/ S.2200-A; Passed Assembly; Labor)
- **4. Comparable Worth** Ensures that public employees of municipalities will be paid equally for work of equivalent value regardless of sex, race or national origin. The bill establishes methodologies that may be used by the president of the civil service commission for determining equivalent value of work and mandates that he or she submit to the legislature and executive a list of those segregated titles for which a wage disparity exists. (A.6448-A; Passed Assembly; Governmental Employees)
- **5. Credit History in Hiring Considerations** Prohibits an employer or potential employer from using an individual's credit history when making decisions to hire, terminate, promote, demote or discipline such individual. (<u>A.8070-B</u>/ S.4905-A; Passed Assembly; Consumer Affairs)
- **6. Criminal Background Information** Directs the Department of Corrections and Community Supervision to both publish a brochure, describing the resources available to the public for the purpose of gathering criminal background information on an individual, and post this same material on its webbsite. (A.8296/ S.5735; Passed Assembly)
- **7. Ban on Novelty Lighters** Prohibits the distribution or sale of novelty lighters, which are equipped with musical sounds, toy-like designs and flashing lights. (<u>A.8402-A/S.7411</u>; Passed Assembly / S.7411; Consumer Affairs)
- **8. Identity Protection** Prohibits businesses from requiring individuals to include unnecessary personal identifying information on forms that are filed with a government agency and made available for public inspection. (<u>A.9111</u>/ S.7819; Passed Assembly; Governmental Operations)

9. Open and Transparent Access to Public Records Bars the state from issuing categorical or blanket denials when records are requested and requires specific justifications for denial of access to records under the Freedom of Information Law.

Additionally, the bill provides that files held by law enforcement agencies or files that which relate to ongoing litigation are accessible when: 1) their disclosure does not interfere with an open investigation or proceeding; and 2) the release of the records has been approved by the judge presiding over the litigation. (A.9460/ S.7818; Passed Assembly; Governmental Operations)

- **10. Protects Employee Online Account Privacy** Prohibits employers from requiring an employee or applicant for employment to disclose information used to access a personal account or service through an electronic communications device. (A.9654/S.6831; Passed Assembly; Labor)
- **11. Expanding Qualified Agency Access to Criminal Records** Amends the definition of qualified agencies to include public defenders, legal aid societies and assigned counsel administrators for the purpose of retrieving criminal history information of clients represented by such individuals or entities. (A.10709/ S.7005-A; Passed Assembly)

V. <u>CODES COMMITTEE PARTICIPATION IN HEARINGS AND</u> ROUNDTABLES IN 2012

A. An examination of "Stop and Frisk" policy and practice.

On May 18, 2012, the Codes Committee, together with the Assembly Committee on Correction and the New York State Black, Puerto Rican, Hispanic and Asian Legislative Caucus, convened a roundtable meeting concerning law enforcement "stop and frisk" policies and practices in New York State.

A police officer must have reasonable suspicion that a crime has occurred, is occurring or is about to occur in order to stop and frisk an individual. This type of stop can be an important component of a law enforcement investigation; an accompanying body pat-down or frisk can also be important for the safety of the officer and persons nearby. However, the number of persons stopped and frisked in New York City has increased significantly in recent years. Approximately ninety percent of these encounters do not end in an arrest. Further, persons of color and ethnic minorities in New York have been disproportionately subjected to these stop and frisk procedures.

The Assembly has repeatedly approved legislation that would require all police departments in the state to implement a policy against racial and ethnic profiling, That legislation would also require police departments to maintain data concerning vehicle and pedestrian stops, and make such information available to assist in efforts to determine whether police agencies may be engaging in ethnic or racial profiling.

The conveners of this roundtable meeting heard from a variety of experts and knowledgeable persons concerning current "stop, question and frisk" policies and practices (primarily in New York City), the perceived impact of these policies and practices on public safety, and the effect of these policies and practices on individuals and families when – as often is the case -- persons who are stopped or detained (sometimes repeatedly) have not, in fact, committed a crime.

B. <u>An examination of the adequacy of outreach and social services</u> for human trafficking victims.

The Codes Committee, together with the committees on Social Services and Oversight, Analysis and Investigation conducted a roundtable on October 16th, 2012 to examine the adequacy of outreach and social services for human trafficking victims. The discussion focused on currently available outreach efforts, social services assistance statewide for human trafficking victims, and identification of gaps, roadblocks and possible solutions to any such gap or roadblock.

When New York State enacted its Human Trafficking law in 2007, it recognized that those persons trafficked were victims, not criminals, and should be treated as such. Therefore, the law includes provisions to provide services for such victims. It is estimated that there could be close to 800,000 victims of human trafficking in New York. Since the enactment of the law, data from service providers, law enforcement and other sources have shown that in comparison to the estimated 800,000 victims, relatively few have been provided with victims services. The roundtable consisted of social and legal service providers as well as representatives from state agencies, who collectively discussed ways to better identify and provide services to victims of human trafficking, from initial point of contact, to long term housing and safety solutions.

The SFY 2012-2013 enacted state budget allocated funds for services for human trafficking victims, which the New York State Assembly supports each year so that trafficking victims can continue to be provided with necessary services.

C. <u>An examination of the adequacy of services available to victims</u> of domestic violence and economic abuse.

The Codes Committee, together with the Judiciary Committee, conducted a hearing on December 5, 2012 to examine how state law and policy can be more effective in addressing economic abuse as a form of domestic abuse, and can better address the economic needs and challenges faced by domestic violence victims. Also discussed was the adequacy of the level of state funding provided for these services.

Economic abuse is a tool abusers may use to intimidate and control their victims. This type of abuse can take many forms, and some victims of domestic violence are unable to remove themselves and their children from the situation because their partner has control of their finances as well as over educational, employment and/or housing opportunities. Others realize, only after leaving an abusive relationship, that their finances are in ruin.

This hearing brought together representatives from the Office of Court Administration, survivors of economic domestic violence, consumer protection groups, legal services and social services groups to discuss how the state can more effectively address the needs of victims of economic domestic abuse. Issues discussed included reforms in the judicial process, the need for financial counseling for victims of domestic violence, enactment of the Consumer Credit Fairness Act, and improving access to civil legal services including in family court matters and financial/consumer legal matters such as credit reporting issues and debt collection abuses.
