PURPOSE: To examine state laws and regulations regarding cybersecurity.

This hearing will examine current state laws and regulations regarding cyber security and to assess the need for further legislation to strengthen consumer protections in this area.

In September, Governor Cuomo announced first-in-the-nation regulations to help protect New York State from the ever-growing threat of cyberattacks. The proposed regulations would require banks, insurance companies, and other financial services institutions regulated by the Department of Financial Services to establish and maintain a cybersecurity program designed to protect consumers and ensure the safety and soundness of New York State's financial services industry.

This hearing seeks to explore the cybersecurity needs of banking institutions to protect both individuals and such institutions from cyber threats.

Persons wishing to present pertinent testimony to the Committee at the above hearing should complete and return the enclosed reply form as soon as possible. It is important that the reply form be fully completed and returned so that persons may be notified in the event of emergency postponement or cancellation.

Oral testimony will be limited to 10 minutes' duration. In preparing the order of witness, the Committee will attempt to accommodate individual requests to speak at particular times in view of special circumstances. These requests should be made on the attached reply form or communicated to the staff as early as possible.

Ten copies of any prepared testimony should be submitted at the hearing registration desk. The Committee would appreciate advance receipt of prepared statements.

In order to further publicize these hearings, please inform interested parties and organizations of the Committee's interest in hearing testimony from all sources.
